BTV ZONE MAP CHANGE PROPOSAL

Purpose

1. To **NOTIFY** the NAMP Technical Committee that bluetongue virus transmission is confirmed in an unexpected location.
 2. To seek **ENDORSEMENT** from the NAMP Technical Committee for a proposed change to the bluetongue virus zone map.
 3. To seek **ENDORSEMENT** from the NAMP Technical Committee for the proposed text to be used in the email alert notification.
- To seek ENDORSEMENT for CONTRACTION of the BTV Transmission Zone in the North-West Slopes region of NSW and corresponding text for the email alert notification (see below).

Description (to be accompanied by the proposed amended zone map(s) as attachment(s))

- BTV seroconversions have not been detected in the Pilliga herd (N199) in the last two years.
- See attached map for proposed zone change (Figure 1)
- Contraction of the zone in this region is critical to allow trade to overseas markets to recommence.

Testing Results

- Site N199 is sampled quarterly from October to June/July. During 2019-20 13-14 animals were sampled and in 2020-21 there were 15 animals in the sentinel herd. No BTV seroconversions were detected over this time period. Simbu virus group seroconversions have also NOT been detected during this period.
- Additionally, BTV seroconversions have NOT been detected in the NAMP herds to the north of N199 (west of Moree).

Following the absence of transmission of bluetongue virus in the North West Slopes region of NSW for the past two years, there has been an increase in the number of properties included in the bluetongue-free zone.
